Submission Method

Once you have prepared your submission in accordance with the guidelines below, the manuscript should be submitted to ArticlesAACDjournal@researchreview.com.au.



Formatting Guidelines

Title page	The manuscript should contain a title page, an outline, and keywords. The title page must have a title that reflects the summary of the article. It must also contain the name of the authors, their contact details, and affiliations. Up to 5 keywords should be provided.
Text formatting	The font should be easily readable and 12 points in size. Times New Roman is an acceptable font. Authors are encouraged to use no more than 3 levels of headings.
Outline	The outline should be approximately 200-300 words and should not contain subheadings. Abbreviations and references to figures, tables or published papers should not be included in the summary.
Tables, Figures & Illustrations	Colour illustrations are encouraged, and will not attract a cost to authors. Digital photographs and artwork can be supplies in the following formats: EPS/TIFF/JPEG. Photographic images should be saved as TIFF/JPEG files with a resolution of 300 dpi at final size. For combination figures or artwork that contains both photographs and labels, EPS/AI/PSD files are recommended.
	Charts and line drawings should be supplied at 300 dpi. Three-dimensional graphs should not be used unless required to present a third dimension of data. Labels must be clearly legible. Colour may be used for charts; if using black and white, the charts should use a patterned print (not shades of grey).
	Figure legends should contain the title of the figure. The title should not be placed on the figure. The figure legend should explain the relevant details and identify parts of the figure; it should not provide an interpretation of the figure. A description of all symbols and abbreviations used in the figure or table and any error values or bars should be defined in the figure legend or below the table.
	Tables and figures should be numbered in consecutive order using Arabic superscript numerals.
Units and Abbreviations	Measurements should be in SI units where possible. The full form of the abbreviation must be defined on first use. Standard abbreviations are used without punctuation e.g. actinic keratosis would be abbreviated as AK.
Medication Names	Generic names must be used; brand names may be inserted in parentheses.
Acknowledgements	This section should list contributions from anyone who does not meet the criteria for authorship (with permission from the contributor). Examples of acknowledgements would include people who provided technical help or writing assistance. Any sources of funding should also be included. If photographs are recognisable, the authors must state that they have obtained permission from the patient to publish.
References	All references should be numbered consecutively in order of appearance and should be as complete as possible. In text citations should cite references in consecutive order using Arabic superscript numerals.

Editorial Policies and Ethical Considerations

Editorial Review and Acceptance	Papers will be considered for publication based on the quality and originality of the research, or the relevance and interest to the field of cosmetic dermatology. With the exception of invited articles and where otherwise stated, manuscripts are double-blind peer reviewed. Papers will only be sent to review if the Editor-in-Chief determines that the paper meets the appropriate quality and relevance requirements. The OPCD policy on the confidentiality of the review process is compliant with COPE's Ethical Guidelines for Peer Reviewers . The Editors retain the usual right to modify the style and length of a contribution and to decide the time of publication. Any major changes to content will be agreed to by the corresponding author. Papers should be submitted exclusively to Opinions and Procedures in Cosmetic
	Dermatology and are accepted on the understanding that they have not been and will not be published elsewhere.
Conflict of Interest	The journal requires that all authors disclose any potential conflicts of interest, including any interest or relationship which may be perceived to influence the author's opinion or objectivity. Examples of conflicts of interest include, patent or stock ownership, membership of a company board of directors, membership of an advisory board or committee for a company, and consultancy for or receipt of speaker's fees from a company. The authors must also declare if they do not have any conflicts of interest. A statement regarding the conflict of interest must be included at the end of the manuscript.
Authorship	The journal subscribes to the ICMJE authorship criteria, where authorship is based on the following 4 criteria:
	 Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work; AND Drafting the work or revising it critically for important intellectual content; AND Final approval of the version to be published; AND Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.
Credits and Permissions	Clinical photographs of recognisable persons: Notice of informed consent and releases to publish photographs of recognisable persons (e.g., face, distinctive tattoo, etc) should be submitted with the manuscript.
	Non-original materials (e.g. quotations exceeding 100 words, any table or figure, including those that have been `adapted from'): Written permission should be submitted for use of non-original material from the original author and/or publisher of the original material. Credit the source in a text or table footnote or at the end of a figure legend, or as a reference.
Ethics Statement	For manuscripts reporting medical studies that involve human participants, a statement identifying the ethics committee that approved the study and confirmation that the study conforms to recognized standards is required, for example: Declaration of Helsinki; US Federal Policy for the Protection of Human Subjects; or European Medicines Agency Guidelines for Good Clinical Practice.
	For manuscripts reporting medical studies on human subjects using a Health Database or Biobank, a statement confirming that the study complies with the World Medical Association's Declaration of Taipei on Ethical Considerations regarding Health Databases and Biobanks is required.
Publication Ethics	This journal uses Grammarly CrossCheck software to detect instances of overlapping and similar text in submitted manuscripts.

Publication Process After Acceptance

Licensing and Copyright	When your accepted article is received by the editorial team, the corresponding author will be requested to sign a publication license agreement.
Proofs	Once the article has been laid out, the journal will email you a PDF proof. The proof must be checked carefully, as the authors are responsible for all statements made, including any changes made during the editorial process. If possible, the proofs should be returned within 14 days.
